Application Requirements Checklist

Eligibility

- Applicant must have completed their initial nursing degree from a school outside of the United States, but are now licensed in the United States
- Applicant must be pursuing education to become a nurse educator or already a nurse educator pursuing additional nursing-education related degrees

Scholarship Proposal Outline

1. Introduction: Describe your need for support and clarity of purpose.
 - *Max. 250 words.*
2. Description of your Program of Study (i.e. dissertation, capstone, scholarly project, pilot project).
 - *Max. 250 words.*
3. Include specific outline, timeline and projected graduation date.
 - If you have completed a dissertation proposal defense or had a DNP project approved, please include defense date. If project has been IRB approved, please indicate.
 - *Max. 500 words.*
4. Describe how your study links to NLN's [mission statement and core values](#).
 - *Max 250 words*
5. Describe your goals as a nurse educator.
 - *Max. 500 words*
6. 2 Letters of recommendation
 - Must be addressed to the NLN Foundation
 - Formal letterhead (preferably one professional and one academic)
 - Letters should address:
 1. Feasibility of completion including confirmation of where applicant is in the process (I.e. IRB approval date, dissertation proposal defense, capstone project approval).
 2. How the project aligns with NLN values
 3. Potential for significant contribution to nursing education
 - *Max. 500 words per letter*
7. **Budget Narrative:** Provide an itemized budget regarding your intention to use the scholarship monies. Be sure that each line item on the budget is clearly justified.
 - *Items not allowable for scholarship monies include cost for certifications, health insurance, or registration/ travel expenses for professional development conferences. However, registration and travel to disseminate outcomes is allowable.*
8. **Bio sketch form** (available on SM Apply).

Please note that there is not a specific application template, however, each application should attempt to follow the order of the checklist and use headings indicative of these requirements. Items 1-7 must be submitted as ONE pdf file and item 8 is submitted separately as a word document. Incomplete applications will be automatically disqualified.
